1. ORGANIZATION

The event is organized by Federació Catalana d'Activitats Subaquàtiques (FECIDAS), with the collaboration of Club Natació Barcelona (Barcelona Swimming Club).

2. COLABORATIONS

4. FACILITY CHARACTERISTICS

The pool measures **50 m** x 25 m, with 10 lanes of 50 m each and a depth of 2 m. Water temperature will be 28 °C (± 1 °C).

The **8 central lanes** will be used for the competition.

8. PARTICIPATION

10. COMPETITION EQUIPMENT

Athletes must compete with equipment that complies with the CMAS Finswimming Rules.

11. TECHNICAL CONTROL AND ARBITRATION

The competition will be controlled by the Comité *Català d'Àrbitres* of FECIDAS, which will appoint the relevant judges.

12. TIMING SYSTEM

Electronic scoreboard.

13. CLASSIFICATIONS AND RESULTS

Individual classifications will be established for each events and gender.

14. PRIZES

Prizes will be awarded to the top three male and female finishers overall.

15. SAFETY AND SERVICES

The organizers will provide the necessary health and safety services.
The sports facility will establish its own internal protocols for use and access.

16. IMAGE RELEASE AUTHORIZATION

Image release authorization is required on the registration form and must be expressly indicated as Yes or No.

Participation implies declaring that you are in adequate physical condition and have the necessary insurance coverage.
FECIDAS declines any responsibility arising from the improper use of equipment or accidents resulting from the sporting activity.
